I ASSERT MY RIGHT TO REMAIN SILENT.

PLEASE LEAVE.



SHOW ME AN I.D.

SHOW ME A JUDICIAL WARRANT.

SLIDE IT UNDER THE DOOR.

- 1 DO NOT OPEN THE DOOR**
Lock all the doors.
- 2 START RECORDING VIDEO**
Ask them to leave.
If they do not leave, go to next step.

- 3 ASK TO SEE AN I.D. AND A JUDICIAL WARRANT**
Ask the agent to slide the warrant and ID under the door or hold it to a window. Take a photo of warrant and ID.

- 4 MAKE SURE THE WARRANT IS CORRECT**
The warrant must have ALL THREE of these items to be a CORRECT Judicial Warrant.
If they show you any **other** kind of warrant, or if they have **no** warrant, they **CANNOT ENTER**.

IF THE WARRANT IS NOT CORRECT:



YOUR WARRANT IS INCORRECT.

PLEASE LEAVE.

TAKE A PHOTO OF THE WARRANT

1 Comes from a COURT

2 Shows your correct name or address

3 Signed by a JUDGE

IF THE WARRANT IS CORRECT: YOU MUST STEP OUT OF THE HOUSE

If ICE enters your home without a warrant



- **IF THEY FORCE THEIR WAY IN**
Say that you don't consent. Then stay silent. Do not answer any questions. Do not show them any documents or sign any documents.



DO NOT ANSWER QUESTIONS



DO NOT RESIST



DO NOT SIGN ANY DOCUMENTS

If you are arrested



- **ASK IF YOU CAN CALL YOUR LAWYER OR PERSONAL CONTACT**
It is likely that ICE will NOT let you make calls, so make sure your personal contact has your lawyer's name and phone number beforehand.



DO NOT ANSWER QUESTIONS



DO NOT RESIST



DO NOT SIGN ANY DOCUMENTS

If you are a witness

- **DO NOT INTERFERE** with ICE operations.
- **VIDEO FROM A SAFE DISTANCE**
- **ASK THE ARRESTED PERSON FOR CONTACT INFORMATION**
- **SEND THE VIDEO**
to the lawyer and to your local immigrant support organization.
Do NOT post on social media
