- **BEFORE ANYTHING HAPPENS:
BE READY TO VIDEO ICE EVENTS**

Make sure someone is ready every day. This could be you or someone else. Record video from a safe distance. Do not interfere with ICE operations. Get video of the whole event including ICE agents, vehicles and license plates.



- **WHEN ICE IS SPOTTED:
CALMLY MOVE STAFF INTO PRIVATE AREAS AND CLOSE THE DOORS.**

ICE is **allowed** to enter **public areas** of a workplace. Public areas include places like the dining area of a restaurant or an office lobby.

ICE is **NOT allowed** to enter **private areas**.

Private areas include kitchens or private offices — any place the public does not enter.



- **ASK TO SEE A JUDICIAL WARRANT**

- **MAKE SURE THE WARRANT IS CORRECT**

The warrant must have ALL THREE of these items to be a Judicial Warrant.

If they show any **other** kind of warrant, or if they have **no** warrant, tell ICE they **cannot enter** private areas.

1 Comes from a COURT

2 Shows your correct name or address

3 Signed by a JUDGE

Take a photo and send it to a lawyer for confirmation before admitting ICE. If the lawyer says it is valid, you must let them in.
